ENTRY FORMALITIES in PORTUGAL

ENTRY VISAS

Portugal is a member of the European Union and Shengen Agreement. Shooters and officials possessing a valid passport can enter Portugal through an international airport or other boarder without problems.

Only nationalities which are not members of the European Union will require entry visas. Those must be obtained from the nearest Portugal consular departments abroad.

The Federação Portuguesa de Tiro com Armas de Caça, or the Organizing Committee of the competition, will be ready – if necessary – to supply special invitation letters to all those nationalities which require a visa to enter Portugal.

CUSTOM FORMALITIES

All participants (except those holding a European Firearms Pass) will be requested upon arrival at airport or other border, to present to customs one Temporary Gun Permit.

In order to obtain a Temporary Individual Gun Permit all shooters coming from outside European Union should contact the Portuguese shooting Federation (www.fptac.pt) - armas.fptac@gmail.com, and fill the form supplied.

European Firearm Pass holders must present the pass at customs upon arrival, also.

Either Temporary Gun Permits or European Firearms Passes must be presented to customs at the time of departure before check-in.

STORAGE FOR GUNS AND AMMUNITION

Holders of a Temporary Gun Permit or a European Firearms Pass are allowed to carry and store freely their guns and ammunition at their hotels during the stay in Portugal.
